### Treasure Coast's stars, CEOs paying big taxes to live large

long with status and prestige, Treasure Coast celebrities and CEOs bring in beaucoup bucks to the local tax collector's offices.

Pop star Celine Dion just shelled out \$171,040 in property taxes for her 3.7-acre oceanfront Jupiter Island estate on the 200 block of South Beach Road.

Dion's estate, which is registered under her Montreal-based company Renlec Management Inc., is on the same street as Richard Fuld Jr., former chairman and chief executive officer of Lehman Brothers. He changed ownership of the \$13.3 million Jupiter Island home at 265 Beach Road exclusively to his wife's name almost two months after the company had the largest bankruptcy filing in U.S. history.

Public records show the couple plunked down \$197,194 in property taxes Nov. 11.

Professional golfer Greg Norman, who slashed the price of his famous barrierisland estate from \$65 million to \$47.5 million last year, also shares the same zip code as the Fulds and Dion. Tax records show Norman paid a whopping \$326,751 in

### Chinese drywall in 100K homes

**PARKLAND** — At the height of the U.S. housing boom, when building materials were in short supply, American construction companies used millions of pounds of Chinesemade drywall because it was abundant and cheap.

Now that decision is haunting hundreds of homeowners and apartment dwellers who are concerned that the wallboard gives off fumes that can corrode copper pipes, blacken jewelry and silverware, and

possibly sicken people.

Shipping records reviewed by The Associated Press indicate that imports of potentially tainted Chinese building materials exceeded 500 million pounds during a four-year period of soaring home prices. The

## **Schools** paying many \$100K+

Superintendent Harry La Cava highest paid administrator on Treasure Coast at \$192,750

In these tight times, pay cuts and layoffs are affecting all ranks of school district employees, from office staff to administrators.

But during the 2007-08 fiscal year, more than 61 Treasure Coast school district administrators earned more than \$100,000.

Now, some of these top earners are bracing for budget

Treasure Coast school superintendents made top dollar with Indian River County Schools Superintendent Harry La Cava taking home the biggest paycheck at \$192,750.

However, for the 2009-10 fiscal year, La Cava is volunteering to take a 10 percent cut from his base salary, about \$17,500.

"If everybody is taking some kind of hit, we're right in the mix of it," La Cava said.

St. Lucie County Schools Superintendent Michael Lannon runs a district almost double the size of Indian River and Martin counties. Including a car allowance, he made \$191,651 in the fiscal year that ended June 30.

Lannon also gave up some money. In 2008, he released the St. Lucie County School Board from having to pay him either a cost-of-living increase or the percentage raise teachers receive.

Martin County Schools newly elected superintendent, Nancy Kline, will have the lowest salary. The state

sets elected superintendents salaries, and Kline is slated to earn \$117,466 for a full year's work. Her salary is about \$40,000 less per year than her predecessor and less than that of Martin County School Board Attorney Doug Griffin.

Griffin made \$132,061 in 2007-08 and is the only Treasure Coast school board attorney who works full time as an on-staff attorney for a school district. The other districts contract with outside attorneys for legal work. St. Lucie paid Dan Harrell
